Covid-19 Update: March 26, 2020

To all in our fellowship:

The Board of Directors of the Castle Rock Clubhouse has continued to closely monitor local, regional, and Federal mandates and recommendations regarding COVID-19. Our goal is and will continue to be carrying our message to those who still suffer, while managing to our responsibility to all in our fellowship and our community.

The Tri-County Health Department issued a 'Stay At Home' Public Health Order for Adams, Arapahoe, and Douglas Counties to take effect at 8:00 a.m. MST on March 26, 2020. Polis has issued a statewide order which takes effect tomorrow morning at 6:00 a.m. MST. http://media.graytvinc.com/documents/colorado+stay+at+home+order.pdf. As the Tri-County Health Department order is the more detailed and restrictive, we will apply its standard moving forward.

The CRC Board of Directors reached out to the TCHD to determine our next steps and were advised we are categorized under the order as a 'Healthcare Provider' which allows us to continue to serve our mission. For this reason, we will remain open and operate under the revised meeting schedule posted at the clubhouse and on our site. **PLEASE NOTE:** As required in the order, meetings held in the clubhouse and those held outdoors are required to follow Social Distancing Requirements as follows.

- 1. Maintaining at least six-foot social distancing from other individuals.
- 2. Washing hands with soap and water for at least twenty seconds as frequently as possible or using hand sanitizer when hand sinks are not available.
- 3. Covering coughs or sneezes (into the sleeve or elbow, not hands).
- 4. Regularly cleaning high-touch surfaces.
- 5. Not shaking hands.

Please be considerate of others in your meetings and of our community at large in following these requirements.

Meetings at the Clubhouse: Per CDC and government regulations, groups with more than 10 in attendance are asked to break into smaller groups and utilize both meeting rooms. There are CDC-generated fact sheets and safety recommendations provided in the meeting rooms. While arrangements have been made to have our Clubhouse professionally cleaned periodically, we need everyone's help in maintaining the safest possible environment before, during, and after each meeting. Cleaning supplies and hand sanitizer are readily available for use. Coffee is not allowed to be made onsite during this period. Additionally, we plan to arrange an exhaustive professional 'deep clean' at the appropriate time.

The Board of Directors will continue to monitor developments at the local, state, and Federal level in seeking guidance on further actions.
